

ORDINANCE NO. 1012

AN ORDINANCE AMENDING THE CITY  
CODE OF THE CITY OF ATLANTIC, IOWA, 2013,  
BY DIVIDING THE CITY INTO FIVE WARDS  
AND FIVE PRECINCTS AND OUTLINING AND  
DESCRIBING EACH WARD AND PRECINCT  
AND REPEALING ORDINANCE NO. 934

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ATLANTIC,  
IOWA.

Section 1. The City Code of the City of Atlantic, Iowa, is amended as follows:  
3.01-In accordance with the 2020 federal decennial census and sections 49.5 and  
372.13(7) of the 2021 Code of Iowa, as amended, the City is hereby divided into five  
wards and five precincts, those wards and precincts are described as follows:

**First Ward**-The First Ward shall consist of all the portion of the City lying within  
the following description:

Commencing at the intersection of the north corporate limits and the east corporate  
limits as the point of beginning; thence along the east corporate limits to Seventh  
Street; thence west on Seventh Street to the eastern boundary of Lot One of  
Steffens Subdivision; thence south on said boundary to Eighth Street; thence west  
on Eighth Street to Plum Street; thence south on Plum Street to Ninth Street; thence  
west on Ninth Street to Mulberry Street; thence south on Mulberry Street to Tenth  
Street; thence west on Tenth Street to the north/south alley between Pine Street and  
Spruce Street; thence north along said Alley to Ninth Street; thence west on Ninth  
Street to Elm Street; thence north on Elm Street to Fourth Street; thence west on  
Fourth Street to Walnut Street; thence north on Walnut Street to Second Street;  
thence west on Second Street to Poplar Street; thence north on Poplar Street to First  
Street; thence west on First Street to Locust Street; thence north on Locust Street to  
the northern tracks of the Iowa Interstate Railroad; thence west along the Iowa  
Interstate Railroad tracks to Buck Creek Road; thence north on Buck Creek Road to  
the north corporate limits; thence east along the north corporate limits to the point  
of beginning.

**Precinct One**-Same boundaries as First Ward.

**Second Ward**-The Second Ward consists of all that portion of the City lying  
within the following description:

Commencing at the intersection of the west corporate limits and Sixth Street as  
the point of beginning; thence east on Sixth Street to Sunnyside Lane; thence south

on Sunnyside Lane to Seventh Street; thence northeasterly on Seventh Street to Palm Street; thence south on Palm Street to Ninth Street; thence east on Ninth Street to Chestnut Street; thence south on Chestnut Street to Thirteenth Street; thence east on Thirteenth Street to Elm Street; thence south on Elm Street to Fourteenth Street; thence east on Fourteenth Street to Maple Street; thence north on Maple Street to Ninth Street; thence west on Ninth Street to Elm Street; thence north on Elm Street to Fourth Street; thence west on Fourth Street to Walnut Street; thence north on Walnut Street to Second Street; thence west on Second Street to Poplar Street; thence north on Poplar Street to First Street; thence west on First Street to Locust Street; thence north on Locust Street to the northern tracks of the Iowa Interstate Railroad; thence west along the Iowa Interstate Railroad tracks to Buck Creek Road; thence north on Buck Creek Road to the north corporate limits, thence west on the north corporate limits to the west corporate limits; thence southwesterly along the west corporate limits to Sixth Street; the point of beginning.

**Precinct Two-Same boundaries as Second Ward.**

**Third Ward**-The Third Ward consists of all that portion of the City lying within the following description:

Commencing at the intersection of Thirteenth and Elm Streets as the point of beginning; thence south on Elm Street to Fourteenth Street; thence east on Fourteenth Street to Bryn Mawr Blvd.; thence south on Bryn Mawr Blvd. to Ridge Road; thence northwesterly on Ridge Road to Chestnut Street; thence south on Chestnut Street to the south corporate limits; thence west along the south corporate limits to the west corporate limits; thence northeasterly along the west corporate limits to Sixth Street; thence east on Sixth Street to Sunnyside Lane; thence south on Sunnyside Lane to Seventh Street; thence northeasterly on Seventh Street to Palm Street; thence south on Palm Street to Ninth Street; thence east on Ninth Street to Chestnut Street; thence south on Chestnut to Thirteen Street; east on Thirteenth Street to Elm Street, the point of beginning.

**Precinct Three-Same boundaries as Third Ward.**

**Fourth Ward**-The Fourth Ward consists of all the portion of the City lying within the following description:

Commencing at the intersection of Ninth and Maple Streets as the point of beginning; thence east on Ninth Street to the Alley between Spruce Street and Pine Street; thence south on said Alley to Tenth Street; thence east on Tenth Street to Plum Street; thence south on Plum Street to Eleventh Street; thence southwesterly on Eleventh Street to Roosevelt Drive; thence south on Roosevelt Drive to Fourteenth Street; thence west on Fourteenth Street to Olive Street; thence south on

Olive Street to the south corporate limits; thence west along the south corporate limits to Chestnut Street; thence north on Chestnut Street to Ridge Road; thence easterly on Ridge Road to Bryn Mawr Blvd.; thence north on Bryn Mawr Blvd. to Fourteenth Street; thence east on Fourteenth Street to Maple Street; thence north on Maple Street to Ninth Street, the point of beginning.

**Precinct Four-Same boundaries as Fourth Ward.**

**FIFTH WARD**-The Fifth Ward consists of all the portion of the City lying within the following description:

Commencing at the intersection of Seventh Street and the eastern boundary of Lot One of Steffens Subdivision as the point of beginning; thence east on Seventh Street to the east corporate limits; thence along the east corporate limits to the south corporate limits; thence west along the south corporate limits to Olive Street; thence north on Olive Street to Fourteenth Street; thence east on Fourteenth Street to Roosevelt Drive; thence north on Roosevelt Drive to Eleventh Street; thence northeasterly on Eleventh Street to Plum Street; thence north on Plum Street to Tenth Street; thence west on Tenth Street to Mulberry Street; thence north on Mulberry Street to Ninth Street; thence east on Ninth Street to Plum Street; thence north on Plum Street to Eighth Street; thence east on Eighth Street to the eastern boundary of Lot One of Steffens Subdivision; thence north along said boundary to Seventh Street, the point of beginning.

**Precinct Five-Same boundaries as Fifth Ward.**

Section 2. All Ordinances or part of Ordinances in conflict herewith are hereby repealed.

Section 3. This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
