I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On Saturday, July 19, 2025, at 0242 hours, Adair County Dispatch took a 911 call of a suspicious vehicle on the roadway outside of 1043 170th Street. The reporting party (RP) told dispatch they were following a truck with a Bradford Built flatbed that was driving with no taillights on. I was responding to the area from near the intersection of Henry A Wallace Road and Adair-Union Street. The plate given was PGU 643, which returned on a Red F250 to the victim, Logan Calkins, of Corning. I attempted to head west on 310th Street to intercept the vehicle as the RP was southbound on Delta Avenue.

Adair County Dispatch continued to update me on the vehicle's location near and into Fontanelle. Once at the Casey's store in the 300 block of Washington Street, I could see the truck heading east bound in the 400 block of Washington Street, still with no taillights on. I passed the RP and caught up with the truck, conducting a traffic stop in the 1300 block of Main Street heading towards the east edge of Fontanelle city limits.

I approached the vehicle and found a female seated in the driver's seat. I informed her of the reason for the stop, no functioning taillights. I asked the female for her license, and she provided an Iowa ID identifying her as the defendant, Katherine Lynn Coleman. The defendant stated she did not have a license and could not give me the name of the person who the truck belonged to. I had her step out and detained her, believing that the vehicle might potentially be stolen. The defendant's last name was not the same as the owner's and the defendant could not explain who the truck belonged to.

I ran the defendant's license information, and she returned with a Suspended NCDL status in lowa, with four withdrawals in effect and indefinite withdrawals on file. I reached out to Adams County Deputy Seaton 2-9 to go to the address of the registered owner, the victim, to see if he had lent the vehicle to the defendant. On speaker phone while speaking with the victim, he stated he had left the vehicle at 1383 State Highway 148, Corning, IA. The victim stated he wanted charges for the theft. The defendant also had not been alerted to the vehicle being stolen, therefore the vehicle had not been entered as stolen.

The defendant did not have permission to have the vehicle from the victim. Post Miranda, the defendant admitted she took the truck because she was tired of walking to Anita, and the truck had the keys in it. The defendant stated she was trying to find someone in Anita and trying to find someone else in Fontanelle. The defendant was charged for Theft 2nd Degree - Motor Vehicle and Driving Under Suspension.
