On 7/16/2025 at approximately 1958 hours, I was driving in the area of South Park Street and Southwest 6th Street when I observed a crowd of people standing in the road and it appeared as if they were yelling at each other.

I exited my marked patrol vehicle and made contact with one of the individuals who advised that the male standing in the grass, later identified as Andrew Irons, had followed a vehicle that his daughter was riding in to that location and began yelling at the drive, identified as Austin Pruitt.

I spoke with Pruitt who advised me that he had pulled up to his friends house to pick her up when Irons approached him aggressively and began yelling at him about his driving. Pruitt explained to me that Irons made statements such as, he would "kick his ass", he "hurts little boys", and he would "kill him". Pruitt then advised that Irons then reached into his truck through the drivers side window, unlocked the door from the inside and opened the door. Pruitt advised that Irons then stated that he was going to pull him out of the vehicle and pull out his adams apple. Pruitt advised that Irons then attempted to grab him out of the vehicle. Pruitt attempted to close his door but Irons held the door open. Pruitt than advised that he was eventually able to close his door and when he did, Irons walked to the passenger side of the vehicle where Pruitt's juvenile girlfriend was sitting. I was advised that she attempted to roll the window up but Irons placed his hands on the top of the window and prevented it from rolling up. Pruitt advised that during this time, Irons continued to yell and threaten them.

I spoke with Irons at his residence. Irons advised that Pruitt had drove by his house and nearly hit his daughters that were in his yard. Irons admitted to being angry but denied the allegations that were made.
