Page County Attorney, James L. Varley, reports the following activities in the Iowa District Court for Page County for the week of June 30, 2025. The Honorable Eric J. Nelson, District Court Judge of the Fourth Judicial District presided. All persons are presumed innocent until proven guilty in a court of law.

Penny Michelle Brown, age 54, Shenandoah, Iowa, appeared with counsel and pled guilty to Assault Causing Bodily Injury. The defendant was sentenced to 29 days in jail, with credit given for time previously served and fined \$430. The fine was suspended, and the defendant was ordered to pay court costs and court-appointed attorney fees.

Zane Edward Gideon, age 19, Shenandoah, Iowa, appeared by counsel and pled guilty to Criminal Mischief in the 4th Degree. The defendant was granted a deferred judgment and placed on probation for 9 months. The defendant was fined \$430 and ordered to pay court costs, surcharges and court-appointed attorney fees.

Danny Dee Lamb, age 50, Clarinda, Iowa, appeared by counsel and pled guilty to Operating While Under the Influence-1st Offense. The Defendant was sentenced to 48 hours of incarceration and was authorized to participate in the Second Chances Program in lieu of the 2 days in jail. The Defendant was fined \$1,250 and ordered to pay court costs, surcharges and court-appointed attorney fees.

Daniel Lee Mattox, age 44, Council Bluffs, Iowa, appeared by counsel and pled guilty to Domestic Abuse Assault Causing Bodily Injury. The Defendant was sentenced to 364 days of incarceration, all suspended and placed on probation for 12 months. As a condition of probation, the defendant shall complete the Iowa Domestic Abuse Program. The defendant was ordered to pay a fine of \$430, plus court costs, surcharges and court-appointed attorney fees.

Eric John Rehfeldt, age 45, Red Oak, Iowa, appeared pro se and pled guilty to Driving While License is Denied or Revoked. The Defendant was fined \$1,000 and ordered to pay court costs and surcharges.

Page County Attorney, James L. Varley, reports the following activities in the Iowa District Court for Page County for the week of July 14, 2025. The Honorable Justin R. Wyatt, District Court Judge of the Fourth Judicial District presided. All persons are presumed innocent until proven guilty in a court of law.

Steven James Baker, age 19, Clarinda, Iowa, appeared by counsel and pled guilty to Operating While Under the Influence-1st Offense. The defendant was sentenced to 45 days of incarceration and fined \$1,250. All but 2 days of the term of incarceration was suspended and the Defendant was placed on probation for 9 months. As a condition of probation, the defendant is to obtain a drug/alcohol evaluation and successfully complete the Drinking Driver's School. The defendant was ordered to pay court costs, surcharges and court-appointed attorney fees.

Tiffany Jo Bredberg, age 54, Shenandoah, Iowa, appeared by counsel and pled guilty to Possession of a Controlled Substance, Marijuana. The defendant was fined \$420 and ordered to pay court costs, surcharges and court-appointed attorney fees.
